Also, for added security, you can **sign up for eStatements** by logging in to [Virtual Branch](#) Online Banking. If you take the time to keep your personal info private and current, you'll help minimize your chances of attracting the wrong type of attention.

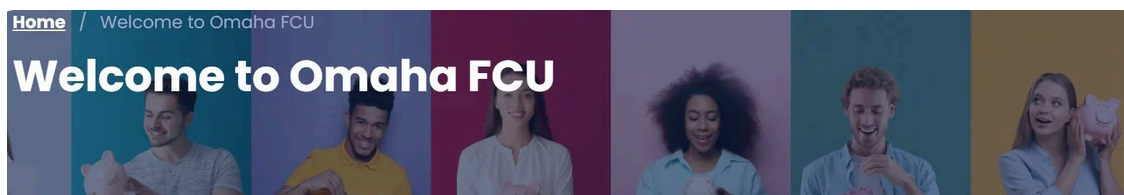
