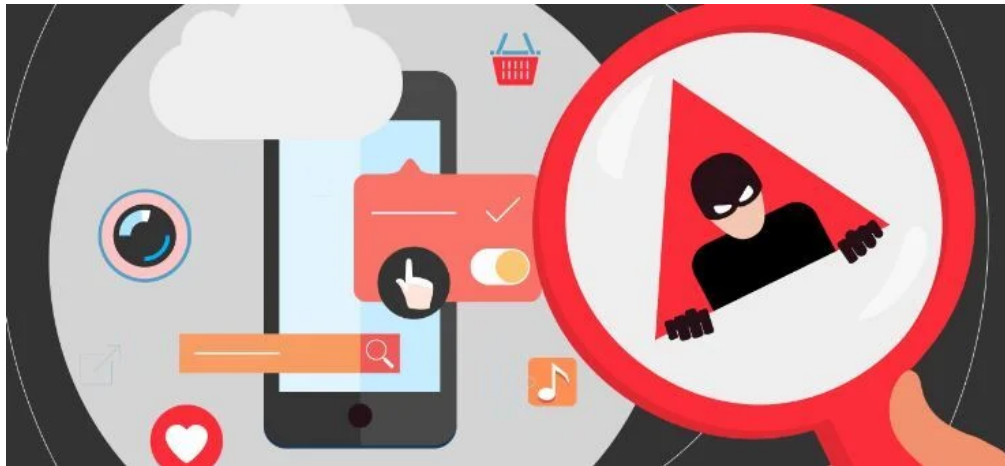

Share Your Care for Vets Sept. 15 thru Nov. 1



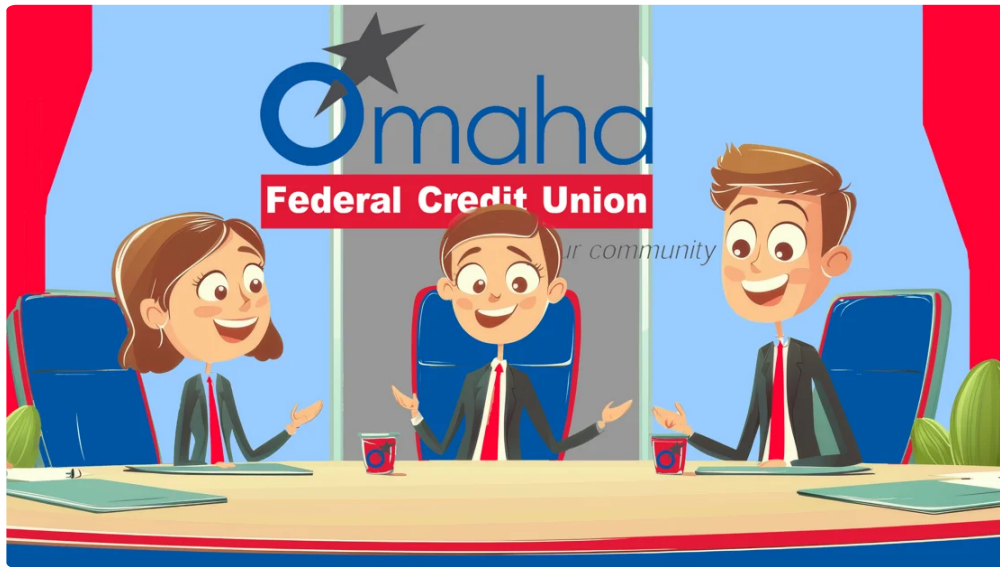

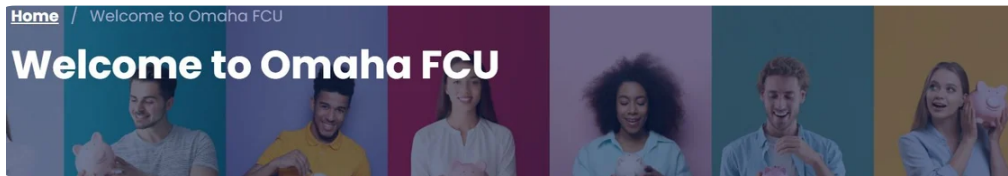

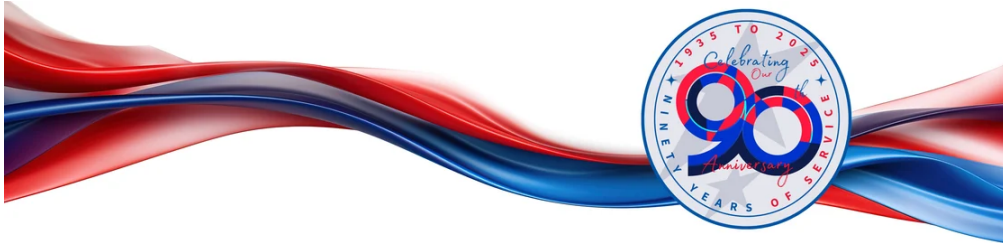
